Payment Terms

Unless stated otherwise in the 'Conditions for Participation', payment for stand hire [and stand construction, if applicable], plus applicable VAT, must be paid over two terms, in accordance with the General Rules and Regulations as stated in Article 6:

1. First advance payment invoice for 25% of the total number of square metres applied for + entry fees within 21 days following the date on the advance payment invoice (these invoices are sent out from 365 days prior to the trade fair).
2. Second advance payment invoice for 100% (minus the 25% in the first advance payment invoice) within 21 days following the date of the second advance payment invoice (these invoices are sent out from 60 days prior to the trade fair).

No advance payment invoices are sent out from 60 days prior to the trade fair. For applications received less than 60 days prior to the first construction day of the trade fair the total amount must be paid **in full** with the application, and in any event be paid before the first day of construction.
